1. Aims

This policy aims to:

- Set out our approach to requiring a uniform that is of reasonable cost and offers the best value for money for parents and carers
- Explain how we will avoid discrimination in line with our legal duties under the Equality Act 2010
- Clarify our expectations for school uniform

2. Our school's legal duties under the Equality Act 2010

The [Equality Act 2010](#) prohibits discrimination against an individual based on the protected characteristics, which include sex, race, religion or belief, and gender reassignment.

To avoid discrimination, our school will:

- Avoid listing uniform items based on sex, to give all pupils the opportunity to wear the uniform they feel most comfortable in or that most reflects their self-identified gender
- Make sure that our uniform costs the same for all pupils
- Allow all pupils to have long hair (though we reserve the right to ask for this to be tied back)
- Allow all pupils to style their hair in the way that is appropriate for school yet makes them feel most comfortable
- Allow pupils to request changes to swimwear for religious reasons
- Allow pupils to wear headscarves and other religious or cultural symbols
- Allow for adaptations to our policy on the grounds of equality by asking pupils or their parents to get in touch with the Headteacher who can answer questions about the policy and respond to any requests

3. Limiting the cost of school uniform

Our school has a duty to make sure that the uniform we require is affordable, in line with statutory [guidance](#) from the Department for Education on the cost of school uniform.

We understand that items with distinctive characteristics (such as branded items, or items that have to have a school logo or a unique fabric/colour/design) cannot be purchased from a wide range of retailers and that requiring many such items limits parents' ability to 'shop around' for a low price.

We will make sure our uniform:

- Is available at a reasonable cost
- Provides the best value for money for parents/carers

We will do this by:

- Carefully considering whether any items with distinctive characteristics are necessary
- Limiting any items with distinctive characteristics where possible
- Limiting items with distinctive characteristics to low-cost or long-lasting items, such as ties
- Considering cheaper alternatives to school-branded items, such as logos that can be ironed on, as long as this doesn't compromise quality and durability
- Avoiding specific requirements for items pupils could wear on non-school days, such as coats, bags and shoes
- Keeping the number of optional branded items to a minimum, so that the school's uniform can act as a social leveler
- Avoiding different uniform requirements for different year/class/house groups
- Avoiding different uniform requirements for extra-curricular activities
- Considering alternative methods for signaling differences in groups for interschool competitions, such as creating posters or labels
- Making sure that arrangements are in place for parents to acquire second-hand uniform items
- Avoiding frequent changes to uniform specifications and minimising the financial impact on parents of any changes
- Consulting with parents and pupils on any proposed significant changes to the uniform policy and carefully considering any complaints about the policy

4. Expectations for school uniform

4.1 Our school's uniform

We take a pride in our uniform and expect all our children to wear it and look smart. It is not compulsory for any of the uniform to be branded with our logo.

All the items with our school logo are available from Monkhouse in Worcester (<https://www.monkhouse.com/school/claines-c-e-primary-school-urn-116793>), and unbranded versions are available from a wide variety of suppliers and high street retailers.

Uniform (October Half term – Easter)

Claines green sweatshirt or cardigan or dark green jumper

Grey trousers (not cords) or grey skirt/pinafore/tailored trousers (no leggings/fashion trousers)

Grey or black socks (with trousers) or white socks/grey tights/green tights (with skirt/pinafore)

Black shoes

KS2 – white long-sleeved shirt and school tie

Reception/KS1 – white polo shirt

Hair bands and ribbons should be dark green or green check only

Uniform (Easter – Sept/Oct)

KS2 – white short sleeved shirt with tie or white polo shirt without tie

Reception/KS1 – white polo shirt

Green check or striped dress or grey skirt with white blouse with short sleeves and reverse collar or white polo shirt (with white socks)

Grey trousers or shorts (with grey or black socks)

Black shoes

Hair bands and ribbons should be dark green or green check only

Please note that KS1 pupils are allowed to wear polo shirts (without ties) throughout the year.

Suitable training shoes are needed for outdoor PE.

Outdoor wear should be essentially warm and waterproof. Coats can be any colour and do not have to be branded.

We ask parents to ensure that the children wear comfortable, sensible shoes to school.

School book bags are encouraged in Reception and Y1 and children can bring in sensible sized backpacks from Y2 onwards.

Waterproofs – can be separate or all-in-ones in any colour

Extra layers in winter – eg fleece top

Jewellery

Children may wear a watch and one pair of small, plain stud earrings. Jewellery must be minimal, safe, and appropriate for the school environment. Hooped or dangling earrings, necklaces, bracelets, rings, and other decorative jewellery are not permitted, as they may pose a safety risk during lessons and physical activities. The school cannot accept responsibility for any jewellery that is lost or damaged. For health and safety reasons, all jewellery must be removed or covered during physical education and sports activities.

Parents wishing to request permission for their child to wear jewellery for religious reasons should arrange to discuss their request with the Headteacher, who will consider it in line with the school's safeguarding responsibilities, health and safety requirements, and its duty to make reasonable accommodations for religious beliefs.

4.2 Where to purchase it

All the items with our school logo are available from Monkhouse in Worcester, and unbranded versions are available from a wide variety of suppliers and high street retailers.

There will be opportunities for second-hand items to be purchased throughout the year, and these opportunities will be shared in the regular newsletters sent out to parents or communicated via Friends.

5. Expectations for our school community

5.1 Pupils

Pupils are expected to wear the correct uniform at all times (other than specified non-school uniform days) while:

- On the school premises
- Travelling to and from school
- At out-of-school events or on trips that are organised by the school, or where they are representing the school (if required)

Pupils are also expected to contact the Headteacher if they want to request an amendment to the uniform policy in relation to their protected characteristics.

5.2 Parents and carers

Parents and carers are expected to make sure their child has the correct uniform and PE kit, and that every item is:

- Clean
- Clearly labelled with the child's name

- In good condition

Parents are also expected to contact the Headteacher if they want to request an amendment to the uniform policy in relation to:

- Their child's protected characteristics
- The cost of the uniform

Parents are expected to lodge any complaints or objections relating to the school uniform in a timely and reasonable manner.

Disputes about the cost of the school uniform will be:

- Resolved locally
- Dealt with in accordance with our school's complaints policy

The school will work closely with parents to arrive at a mutually acceptable outcome.

5.3 Staff

Staff will closely monitor pupils to make sure they are in correct uniform. They will give any pupils and families breaching the uniform policy the opportunity to comply, but will follow up with the headteacher if the situation doesn't improve.

Ongoing breaches of our Uniform Policy will be dealt with by the school's Behaviour Policy.

In cases where it is suspected that financial hardship has resulted in a pupil not complying with this uniform policy, staff will take a mindful and considerate approach to resolving the situation.

5.4 Governors

The governing board will review this policy and make sure that it:

- Is appropriate for our school's context
- Is implemented fairly across the school
- Takes into account the views of parents and pupils
- Offers a uniform that is appropriate, practical and safe for all pupils

The board will also make sure that the school's uniform supplier arrangements give the highest priority to cost and value for money, for example by avoiding single supplier contracts and by re-tendering contracts at least every 5 years.

6. Monitoring arrangements

This policy will be reviewed every two years by the Headteacher. At every review, it will be approved by the Full Governing Body.
